WHEREAS, on Committee's recommendation, said budget was read, deliberated and approved on second reading in the regular session of the Council on November 21, 2012 and the same was scheduled for third and final reading on the next session;

WHEREAS, as scheduled, said Ordinance was finally read and approved in the regular session of the Sangguniang Bayan on November 28, 2012;
